TOTAL FELON ADMISSIONS

The total felon admission for calendar year 2013 was 37,651.

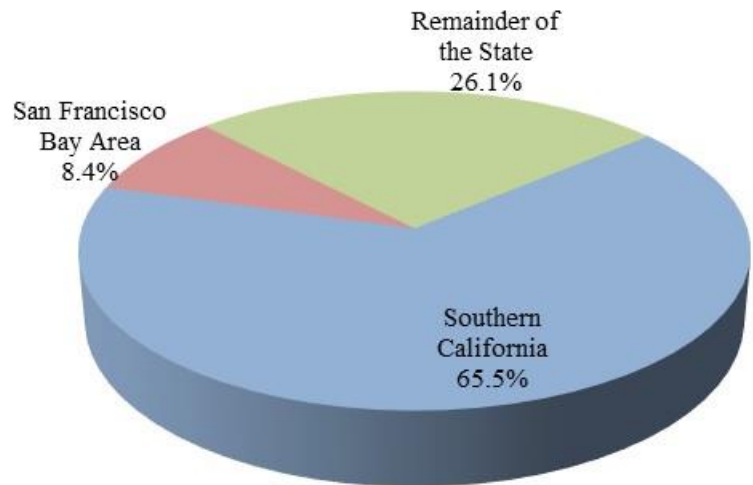
- The total felon admission population includes:
 - 31,367 felon new admissions.
 - 6,284 felon PV-WNTs
- The number of male felon new admissions increased from 24,384 in 2012 to 28,975 in 2013. The number of female felon new admissions increased from 1,896 in 2012 to 2,392 in 2013.
- The number of male PV-WNTs decreased from 7,426 in 2012 to 6,023 in 2013. The number of female felon PV-WNTs decreased from 284 in 2012 to 261 in 2013.

AREA OF COMMITMENT

During calendar year 2012:

- 24,668 (65.5%) of the total felon admissions were from Southern California.
- 3,159 (8.4%) were from the San Francisco Bay Area.
- 9,824 (26.1%) of the total felon admissions were admitted from the remainder of the state.

DEFINITIONS

New Admission: The first commitment from court.

Parole Violator Returned With a New Term (PV-WNT): A parolee who has received a court sentence for a new crime and been returned to prison.

Age: The age of the offender at the time of admission.

NOTE:

1. The total admissions are based on the number of inmates received from court, who enter a California Department of Corrections and Rehabilitation (CDCR) adult institution during a calendar year.
2. Based upon a felon's first status, only new admissions and parole violators returned with a new term are included. Parolees, who return to CDCR with a return status of Parolee Returned to Custody (PRTC) or Pending Revocation (PENDREV) and, while in prison, have their return status changed to PV-WNT, are excluded.
3. Inmates who were received by CDCR and released to parole on the same day (paper moves) are not included.
4. Civil Narcotic Addicts, County Diagnostic Cases (under Penal Code Section 1203.09), some Youth Authority commitments, federal prisoners and prisoners from other states are excluded.
