The Case Records Unit is responsible for administering and managing the Statewide Uniform Case Records System. The unit provides departmental and outside law enforcement staff with comprehensive information in order to make critical decisions that affect inmates and parolees.

In regards to Public Safety Realignment, the Case Records Unit is charged with preparing a pre-release and post-release packet for every offender who goes on Post-Release Community Supervision (PRCS). Please refer to **Appendix A** for listings of the documents contained in both the Pre and Post-Release Packets.

In addition, the Case Records Unit has developed a Time-Calculations Handbook. This handbook provides an explanation and examples of how CDCR performs time-calculations for each offender who comes into CDCR's jurisdiction. However, it is important to understand that CDCR provides the time-calculation explanation only as a sample and does not intend for it to be a recommendation or endorsement of CDCR's methods for doing the calculations. It is for each county to decide its own respective time-calculation methodology.

Common Processes

1. HOW DO I NOTIFY DAPO WHEN A PAROLEE IS BEING RELEASED PRIOR TO COMPLETING REVOCATION TIME?

You can send an e-mail to the Agent of Record by accessing LEADS and entering the CDC number. If you do not have access to LEADS, access the link that follows, select the Region for a listing of field units and contact information. Or you can contact the Re-Entry Unit to obtain contact information for the supervising field unit.

2. WHO DO I CONTACT IF PROBATION RECEIVES A COURT WALK-OVER WHO SHOULD BE SUPERVISED BY DAPO?

You can contact the respective Re-Entry Unit listed at the bottom of this page. The appropriate Unit for that Parole Region will identify the DAPO field unit the offender will be assigned to.

3. HOW CAN I OBTAIN CASE INFORMATION FOR AN OFFENDER ON PRCS WHO WAS PREVIOUSLY SUPERVISED BY DAPO?

You can access case information by entering offender's CDC number in LEADS. If you do not have access to LEADS, you can contact the respective Re-entry Unit listed in the chart at the bottom of this page.

Notification Processes for Parole Agent Pick-Ups

On occasion, the Division of Adult Parole Operations (DAPO) may identify an offender whose case factors warrant an Agent pick-up, in lieu of a direct release to the community at the completion of serving a period of revocation.

In the event an offender warrants an Agent pick-up, the following will occur:

1. If known at the time the hold is placed, the Agent of Record will inform CDCR's Warrants Unit to include a request for an Agent pick-up in a message sent to county. The Warrants Unit will note on the notice issued on the California Law Enforcement Telecommunication System (CLETS): "Agent pick-up required at time of release from custody; please notify CDCR two business days prior to an early release."
2. If it is determined, after the hold has been placed, that Agent pick-up is required, the Agent of Record will notify the county jail immediately upon discovery of need for Agent pick-up via CLETS.
3. As follow-up, the Agent of Record will ensure a CLETS message is sent to the county jail a minimum of 48 hours prior to the scheduled release.
4. The county jail will keep the offender in custody on the date of the release until the Agent of Record arrives to pick up the offender or until 1700 hours, whichever occurs first.

If the county jail is going to release the offender prior to the completion of their revocation process, or prior to the completion of the parolee serving their period of revocation, the county will:

1. Notify the Agent of Record via LEADS e-mail or CLETS that the offender is scheduled to be released early. Notification will be two business days prior to the release.

2. Keep the offender in custody on the date of the release until the Agent of Record arrives to pick-up the offender, or until 1700 hours, whichever occurs first.

Notification Processes for Complex Cases

On occasion, DAPO may have an offender with complex case factors resulting from mental and/or medical health issues, in the custody of the county jail, as the result of a violation of the conditions of parole.

The County Jail medical and mental health staff may determine that it is in the best interest of the offender and the State to make efforts to identify treatment needs in advance of the offenders release to the community.

Offenders who meet the below criteria may warrant notification to the Agent of Record or DAPO’s Parolee Medical or Mental Health Units by the County Jail’s mental/medical health personnel.

The specific criteria for complex cases include:

1. Inmates requiring acute care, long-term medical care, or inpatient mental health care;
2. Inmates in need of board & care-assisted living, in-home health care, and hospice.;
3. Inmates diagnosed with HIV/AIDS;
4. Inmates with a chronic illness in need of life sustaining treatment (i.e., dialysis, continuous oxygen); and
5. Inmates designated as Enhanced Outpatient Program (EOP) by CDCR.

The goal of CDCR's Division of Rehabilitative Programs (DRP) is to provide effective evidence based programming to adult offenders and to create strong partnerships with local governments, community based providers, and the communities to which offenders return in order to improve rehabilitative outcomes and reduce recidivism.

DRP's programs fall into one of two areas:

- Office of Offender Services (OS)

DRP's Evidence-Based Approach

Assembly Bill 900, the Public Safety and Offender Rehabilitation Services Act of 2007, altered the way the California Department of Corrections and Rehabilitation (CDCR) offers programming to offenders. This important legislation was designed to fundamentally reform California's system of incarcerating offenders - to improve public safety by reducing the rates at which offenders re-victimize communities and return to prison. An Expert Panel on corrections reforms, assembled from across the country, provided guidance on the most effective practices and methods to implement reforms. CDCR led the effort to bring this expertise, including the latest science and proven practices, to help offenders succeed, reduce prison overcrowding, lower recidivism, and save taxpayer costs.

A large part of this effort was the implementation of assessment tools in assigning offenders to rehabilitative programs. The California Static Risk Assessment (CSRA) uses an offender's past criminal history and characteristics (such as age and gender) to predict the likelihood of reoffense. Offenders are also assessed using the Correctional Offender Management Profiling for Alternative Sanctions (COMPAS), an evidence-based tool to identify an offender's criminogenic needs, i.e., those factors that put an offender at risk to reoffend. The CSRA has been integrated into COMPAS and both are used to place the right inmate into the right program at the right time.

Information That Will Be Available Upon Release to Post Release Community Supervision (PRCS)

When an inmate is released from CDCR and placed on Post Release Community Supervision (PRCS), they will have a CDCR Form 611 in their possession and a copy will have been sent to the county. If an offender received a COMPAS assessment, the most recent one will be included in the packet. If the "SAP" box is checked on the form, this indicates the offender was enrolled in a substance abuse program while in prison. An offender will also have additional information in their possession that they can share with their probation officer.

An offender may have some or all of the following information:

- Test of Adult Basic Education (TABE) score (in a chrono);
- Comprehension Adult Student Assessment System (CASAS) score (in a chrono);
- A diploma or a vocation certificate if they completed an in-prison program (inmate should have a copy);

- A certificate of completion from the California New Start Prison to Employment Program (if completed), which will allow an offender to access enhanced services at their local One-Stop Career Center; and/or
- An official California State identification card (if the offender participated in CDCR's ID Project).

There is a national General Education Development (GED) website that provides GED Chief Examiners access to a database, which contains the names of GED completers. Probation officers can locate the GED Chief Examiners at their local County Office of Education or their local High School District Office.

Division of Rehabilitative Programs

Office of Offender Services

The Office of Offender Services (OS) is comprised of two divisions: in-prison and community reentry services. The OS is responsible for offering substance abuse treatment, employment, reentry, and other parolee programs.

Substance Abuse Treatment Programs

CDCR's Substance Abuse Treatment (SAT) programs are designed to provide in-prison substance abuse services followed by a fully integrated community-based services model. SAT inmates participate in evidence-based cognitive behavior therapy program while incarcerated. Because research has shown that extended exposure to a full array of services during periods of incarceration and parole provides the most favorable opportunity for reducing recidivism and criminal activity, a smooth transition is critical to the successful reintegration of SAT participants into society. For this reason, CDCR is committed to working with counties to support this reintegration process.

As of August 2011, DRP has an annual capacity to serve approximately 3,800 inmates with substance abuse treatment in prison. These programs are available at the following 12 institutions:

California New Start Prison to Employment Program

In June 2009, the California New Start program began providing employment opportunities through direct linkages for ex-offenders to various One-Stop Career Centers statewide. Core services, such as job search seminars, individual employment plans, job development workshops, supportive service referrals, employment referrals, and job retention follow-up are available through this program for offenders upon parole. These employment services facilitate an offender's successful reentry, reduce recidivism, and enhance public safety.

Internal Transition Component

The In-Prison Transition component delivers vocational training for inmates and prepares them to immediately receive employment upon release by collecting right-to-work documents and offering job skills development. In addition, this program links inmates to One-Stop Career Centers and social service agencies in their counties of residence to ensure access to resources and employment upon release. Through interagency agreements with CDCR, the Local Workforce Investment Boards have been charged with delivering the Transition component. This program is currently in operation at:

- Folsom State Prison
- California State Prison, Solano
- Valley State Prison for Women
- Richard J. Donovan Correctional Facility

Inmate participation in this program is on a voluntary basis as long as the inmate is age 18 or over and scheduled for release within 60 days to 120 days. The Transition program is taught by Employment Specialists from the Local Workforce Investment Board from each assigned county. The curriculum is divided into eight modules with the following topics: Transition Planning; Job Search, Parts I and II; Job Applications; Winning Resumes; The Interview; One-Stop Career Center Orientation; and Financial Literacy.

All offenders, including those who will be released to PRCS, are eligible for these services. Offenders who complete the Internal Transition Component will receive a certificate of completion which will allow them to access additional services through the external component.

Community Component

In 2008, CDCR's Secretary and the Secretary of the Labor and Workforce Development Agency entered into a Memorandum of Understanding establishing a working partnership focused on improving the reintegration of parolees into local communities. CDCR partnered with the California Workforce Investment Board to establish the necessary direct connection to local job markets. The CWIB and its well-established infrastructure of 49 LWIBs and 200 One-Stop Centers around the State are authorized by federal law to provide employment assistance to all Californians, including parolees. The One-Stop Centers are uniquely positioned as an existing link to the workforce for returning parolees as they reintegrate into their communities as productive citizens. This recognized partnership led to the formal implementation of the California New Start – Prison to Employment program. This program utilizes federal Workforce Investment Act funds. An inmate being released to PRCS can access the external component if they have a certificate of completion from the internal component.

California Identification Project

In September 2010, CDCR committed to working in collaboration with the California Prison Industry Authority and the Department of Motor Vehicles to administer the California Identification (ID) Project pilot program. The goal of this program is to provide official California ID cards for paroling inmate populations at nine pilot institutions. Facilitators conduct workshops that can accommodate up to 40 offenders and provides assistance on filing the proper application for ID renewals. Inmates being released on PRCS are eligible for the ID project.

The average offender in California's prisons reads at an eighth-grade level. Education is a key to successful release and integration. Without the ability to read, write, do math, solve problems, and access/use technology—today's adults will struggle to take part in the world around them and fail to reach their full potential. Inmates who learn these skills are far more likely to succeed upon release.

In order to reduce re-victimization and recidivism, CDCR is committed to preparing inmates for a successful reintegration into their communities by offering them various educational opportunities. Thirty-two of CDCR's 33 prisons maintain fully accredited schools (the 33rd school is currently undergoing the accreditation process). Accreditation is provided by the Western Association of Schools and Colleges. Education programs are administered by CDCR's Office of Correctional Education (OCE). Through OCE, each institution makes available a variety of Academic and Career Technical Education programs statewide. CDCR can currently provide academic education services to about 32,000 offenders in prison. Our academic teachers provide inmates with instruction in Literacy, Adult Basic Education, and Adult Secondary Education. The Department also works with several college programs so inmates may access post secondary education at their own expense. Education levels are based on the offenders' academic needs, which are determined through standardized testing. Career Technical Education Programs provide training in various fields. Some of these fields include construction, automotive repair, computer software for the business setting and electronics. Currently, CDCR has capacity for approximately 4,900 participants in these classes.

- Comprehension Adult Student Assessment System (CASAS) score (in a chrono)
- A diploma or a vocation certificate if they completed an in-prison program (inmate should have a copy)

There is a national General Education Development (GED) website which provides GED Chief Examiners access to a database which contains the names of GED completers. Probation officers can locate the GED Chief Examiners at their local County Office of Education or their local High School District Office. The database can be accessed at:

PRE-RELEASE PROCESS

The California Department of Corrections and Rehabilitation Correctional Counselor Pre-Release Overview for Counties

The following is an overview of the Correctional Counselor Pre-Release Process:

210 Days Prior to the Inmate's Scheduled Release:

- The Correctional Counselor (CC) interviews the inmate and reviews their central file to complete the CDCR Form 611, Release Program Study (RPS).
- Screening for Post Release Community Supervision is conducted at this time utilizing the central file, and the High Risk Sex Offender (HRSO) screening conducted by the Department of Adult Parole Operations.
 - HRSO screening conducted by using the Static 99.
- If the inmate is PRCS eligible, the CC also issues the CDC Form 1515-CS, Notice and Conditions of Post Release Community Supervision.
 - If the inmate refuses to sign the Notice and Conditions of Post Release Community Supervision, the inmate will be issued a CDC Form 115, Rules Violation Report (disciplinary).
 - If found guilty, the inmate will be assessed a 30 day Loss of Credit, which is restorable.

180 Days Prior to the Inmate's Scheduled Release:

- The completed RPS is due to be delivered to the Classification and Parole Representative (C&PR) or CC III at the Reception Center (CC III RC).
 - The information on the RPS is reviewed for accuracy.

120 Days Prior to the Inmate's Scheduled Release:

- The C&PR/CC III RC forwards the completed RPS and other required documents from the inmate's central file to the appropriate county. (Refer to CDCR Website or Handbook for additional information on Pre-Release documents sent to the Counties.)

Upon receipt of the completed RPS, the County should:

- Complete Section V of the RPS, County Reporting Instructions.
- Determine the requirement for additional Conditions of Supervision.
- Return the Completed RPS to the institution.

60 Days Prior to the Inmate's Scheduled Release:

- The CC will provide the inmate with their copy of the RPS, complete with Reporting Instructions.
- The CC will provide the inmate with any Special Conditions of Release imposed by the County.

Imminent Releases (60 days or less to scheduled release):

- Counties will receive verbal notification and expedited processing of the CDCR Form 611 and standard pre-release documents in cases with imminent release dates.

Changes in the Scheduled Release Date or Supervision Determination:

- At any time prior to release that the inmate's scheduled release date or supervision determination change, the County will be notified at once.

Additional Information for Counties Upon Release of the Inmate:

- Inmates released from CDCR to PRCS shall have their information available to local law enforcement through the Parole Law Enforcement Automated Data System (LEADS), and will include a photograph.

Post-Release Documents:

- Post Release documents will be forwarded to the County within 48 hours of the inmate's release from prison. (Refer to CDCR Website or Handbook for additional information on Post-Release documents sent to the Counties.)

CRITERIA FOR REALIGNMENT

Criteria Related to Realignment

PRCS Criteria

PC Section 3450 provides that the following inmates shall be released to CDCR parole supervision:

- An inmate serving a current term for a violent felony, as described in PC Section 667.5(c)
- An inmate serving a current term for a serious felony, as described in PC Section 1192.7(c)
- An inmate serving a current life term
- An inmate determined by the California Department of Corrections and Rehabilitation to be a High Risk Sex Offender (HRSO)
- An inmate determined to be a Mentally Disordered Offender (MDO)
- PC Section 3000.08 exclusion

Current term is defined as a court sentence the inmate is serving and has not yet been released for a period of parole supervision.

High Risk Sex Offender

An HRSO is a sex offender who is required to register pursuant to PC Section 290 and has been determined to pose a higher risk to commit a new sex offense in the community by a risk assessment tool. The following risk assessment tools are utilized by CDCR:

- STATIC 99R for males
- FSORA for females

Static 99R scores reflect 4 or 5, medium – high, and 6+ high. CDCR makes HRSO determinations for 4 and above.

Mentally Disordered Offender

A Mentally Disordered Offender is an offender who meets the criteria pursuant to PC 2962, thus representing danger of physical harm to others.

Stayed or Stricken Counts and Enhancements

The following are exclusionary for PRCS when reviewing an inmate's current commitment for serious and violent felony offenses:

- Qualifying stayed counts
- Qualifying stayed enhancements
- Qualifying enhancements where the punishment is stricken

Juvenile Adjudications

A juvenile adjudication is not a felony conviction. Because juvenile adjudications are not considered convictions, they cannot be considered as a prior for purposes of AB 109. As such, juvenile adjudications are **not** exclusionary for PRCS.

ELIGIBLE POPULATION

Parole Violators Return to Custody

Parole Violators Return to Custody (PVRTC) may be eligible for PRCS if they:

- Are serving a period of revocation for a violation committed prior to October 1, 2011; and
- Have a release date on or after November 1, 2011.

Parolees in State prison either pending revocation or designated PVRTC on October 1, 2011, and released from a prison on or before October 31, 2011, shall not be screened and shall be released to CDCR parole.

The current term for PVRTC is defined as the commitment(s) for which the inmate is serving the most recent parole period.

Parole Violators with New Terms

Parole Violators with New Terms (PVWNT) who are released on or after October 1, 2011, shall be screened for PRCS determination.

In the cases where the inmate is a PVWNT and the controlling release date is the parole violation, i.e., Revocation Release Date, the inmate shall be screened utilizing the commitment offense that resulted in the new term.

If the PVWNT meets PRCS criteria, their prior parole term will be discharged upon release.

If the PVWNT's active parole term is over three years pursuant to PC 3000.08, they will not be eligible for PRCS.

INITIAL IMPLEMENTATION PROCESS

Cases Currently in the Pre-Release Process

Generally, the pre-release process begins six months prior to the inmate's release from prison. Because Realignment began October 1, 2011, inmates with release dates from October 1 through February 2012 had to be rescreened to determine eligibility for PRCS. The following is the schedule for Correctional Counselor (CC) staff and Case Records staff for re-screening and processing these cases:

Scheduled Release Date	Send to County
October 2011	August 29
November 2011	September 23
December 2011	October 7
January 2012	October 28
February 2012	November 10

While rescreening for these cases is occurring, staff are also processing cases falling within normal pre-release timeframes.

Normal Pre-Release Process

As mentioned above, the normal pre-release process generally begins six months prior to the inmate's release from prison. Refer to the **Correctional Counselor Pre-Release Overview for Counties** for specifics of the normal process.

Parole Law Enforcement Automated Data System (LEADS)

Pursuant to PC Section 3450, inmates released from CDCR to PRCS shall have their information available to local law enforcement through the Parole Law Enforcement Automated Data System (LEADS), and will include a photograph.

INTAKE PROCESS

Reception Center Intake Screening

Offenders convicted on or after October 1, 2011, shall be convicted of one or more of the following in order to be committed to CDCR:

- Current or prior serious felony conviction(s) pursuant to Penal Code (PC) Sections 1192.7(c) and 1192.8. This includes out-of-state convictions, stayed counts, and enhancements. Juvenile court sustained adjudications are not included; however, a juvenile tried and convicted as an adult is a conviction.
- Current or prior violent felony conviction(s) pursuant to PC Section 667.5(c). This includes out-of-state convictions, stayed counts, and enhancements. Juvenile court sustained adjudications are not included; however, a juvenile tried and convicted as an adult is a conviction.
- A life term.
- A requirement to register pursuant to PC Section 290.
- A current conviction for an offense identified in statute requiring CDCD commitment (see attached offense listing).

Cases Determined to Be Ineligible for CDCR

If an inmate is determined to be ineligible for housing within CDCR and the commitment documents do not remand the offender to CDCR, the institution shall contact the appropriate county to advise of the inappropriate delivery and make arrangements for an expeditious return of the offender to the county.

If an inmate is determined to be ineligible for housing within CDCR and the commitment documents remand the offender to CDCR, designated staff shall ensure a letter to the county, Abstract of Judgment and Minute Order are faxed to the court of the county of commitment, the district attorney, and the attorney of record to request amended commitment documents. Once received, the inmate will be returned to the county of commitment.

County Delivery of Parolees Pending Revocation (PendRev) and Parole Violators Returned to Custody (PVRTC) Effective October 1, 2011

Realignment legislation mandates parolees arrested on or after October 1 for a parole violation shall serve their period of confinement in the county jail. The Reception Centers will no longer receive PendRevs or PVRTCs who are arrested on or after October 1.

High Risk Release

PC 3060.7, High Risk Release

Public Safety Realignment legislation amended PC Section 3060.7 to include those inmates released to PRCS. PC Section 3060.7(a) now states in part, "...the parole authority shall notify any person released on parole or postrelease community supervision pursuant to (Title 2.05 (commencing with Section 3450) of Part 3 of the Penal Code) who has been classified by the Department of Corrections as included within the highest control or risk classification that he or she shall be required to report to his or her assigned parole officer or designated local supervising agency within two days of release from the state prison."

The following offenders are classified by CDCR as the "highest control or risk classification" pursuant to PC Section 3060.7

- Has a California Static Risk Assessment (CSRA) risk number value of 5; or
- Is required to register as a sex offender pursuant to PC Sections 290 through 290.023.

Inmates designated as PRCS cases subject to release pursuant to PC Section 3060.7 require an adjustment to their release date if the established release date falls on a Friday or the day before a State holiday, and shall be released consistent with existing policy as described below.

- An inmate sentenced before January 1, 1996, will be adjusted backward.
- An inmate sentenced on or after January 1, 1996, will be adjusted forward.

Inmates subject to PC Section 3060.7 who are scheduled to release on a Friday will have their release date adjusted as follows:

- If the inmate was sentenced before January 1, 1996, the date is adjusted back to Wednesday.
- If the inmate was sentenced on or after January 1, 1996, the date is adjusted forward to Sunday.

PC Section 3060.7, Holiday Release Date Adjustments Schedules

There are exceptions to the release date adjustments noted above when a holiday falls close to the scheduled Friday release date. Please refer to the Penal Code Section 3060.7 Holiday Release Date Adjustment for the Year 2011 schedule for inmates whose release date falls the day before or a holiday.

During the ten-day audit process prior to release, Case Records staff shall notify the appropriate county by sending the "Notification to County of Change in Status Prior to Release of Postrelease Community Supervision Inmate" form via fax or email, ensuring a verified receipt of delivery.

It is the responsibility of the county to determine whether they will provide alternate reporting instructions and provide that information to the institution.

CDCR Form 611, Release Program Study (Rev. 07/11) Revisions Outlined

Revisions to the CDCR Form 611, Release Program Study (Rev. 10/06) and documented on the CDCR Form 611 (Rev. 07/11) are outlined below:

1. The document has been separated into Section I through Section IX.
2. Section I, Case Factors, includes a box titled, Criminal Identification and Investigation (CI&I) number.
3. Section I, Case Factors, "Referred to DMH pursuant to 2962 PC, 6601 W&IC" Box has been moved from the bottom of the form to the top of the form.
4. Section II, Notification and Registration Requirements/Special Interest, HRSO Box has been moved to Section III, Supervision Determination by Correctional Counselor.
5. Sections II, Special Interest, the acronyms for PIC, SAP, and SHU have been written out.
6. Section III, Supervision Determination by Correctional Counselor, CCs shall complete this section using the "current term" only. The "current term" is defined as a sentence the inmate is serving and has not yet paroled. CCs shall use the Minute Order and/or Abstract of Judgment to make this determination.
7. Section III (a), Supervision Determination by Correctional Counselor, CCs shall determine if the current term is a conviction for PC Section 667.5(c) and/or PC Section 1192.7(c) or 1192.8 utilizing the current Case Records serious and violent felony listing and check the appropriate box if applicable. If the inmate is serving a life sentence including three strikes sentence to Life, check the respective box.
8. Section III (b), Supervision Determination by Correctional Counselor, CCs shall document the HRSO score on the line beside the box, regardless of the number. If the HRSO score is 1, 2, or 3, the HRSO Box is left blank. If the HRSO score is 4, 5, and 6 or higher, the CC shall mark the HRSO box. Inmates, who are not required to register pursuant to PC Section 290, shall have the "Not applicable" Box checked.
 - To obtain the HRSO score, log into COMPAS CORE, enter the CDCR number, click on "search" on the right hand side of the screen. Under "Offender List," double click on the CDCR number. Under "Other Screening," double click on the date. On the STATIC 99 Screening Summary screen, upper right hand of the screen is the HRSO score.
 - If there is no HRSO score, the CC shall contact the local Parole Planning and Placement staff to obtain the score.

9. Section III (c), Supervision Determination by Correctional Counselor, if any one or combination of boxes is checked in III (a) and III (b), except "Not applicable," the inmate shall be released to parole and the appropriate Region I, II, III, or IV is checked consistent with current policy.
10. Section III (d), Supervision Determination by Correctional Counselor, if the boxes in III (a) and III (b) are blanks, except "Not applicable," check the box titled, "Eligible for County Supervision."
11. Section IV, Supervisor Review and Approval of Screening Determination, CC Supervisors shall be required to review and approve the CC determination by checking the appropriate box as indicated on the form, then clearly print, sign, and document the date of the decision.
12. Section V, County Agency Reporting Instructions, shall be completed by the appropriate County Agency and returned to CDCR.
13. Section VI, CDCR Parole Reporting instructions, is completed by DAPO and only adds a box for the Re-Entry Screener to print their name in addition to signing their name.
14. Section VII, Caseworker Evaluation, information has been moved from the front page to the back page.
15. Section VIII, Serious Disciplinaries, information has been moved from the front page to the back page. If the Security Housing Unit box is checked on the front of the form in Section II, Special Interest, the CC is required to document the disciplinary section.
16. Section IX, Medical/Psychiatric, information has been moved from the front page of the CDCR Form 611 to the back page.

All other information found previously on the CDCR 611 (Rev. 10/06) remains the same on the CDCR 611 (Rev. 07/11). There are no changes to the documentation requirements.

1. You are scheduled to be released on PostRelease Community Supervision effective _____. Pursuant to Penal Code section 3450, you are subject to community supervision provided by a county agency for a period not exceeding three years. Release to county supervision is subject to the following notice and conditions. Should you violate conditions of this release or violate the law, you can be incarcerated in county jail regardless of whether or not new charges are filed.
 - a. You waive extradition to the State of California from any state or territory of the United States or from the District of Columbia. You will not contest any effort to return you to the state of California.
 - b. If the supervising agency determines, based upon psychiatric reasons, that you pose a danger to yourself or others, the court may, if necessary, order your placement in a community treatment facility for psychiatric treatment.
 - c. You and your residence and any other property under your control may be searched without a warrant day or night by an agent of the supervising county or any peace officer or law enforcement officer. You may be subject to arrest with or without a warrant by a peace officer employed by the county agency or, at the direction of the supervising county agency, or by any peace officer when there is probable cause to believe there is a violation of the terms and conditions of release.
 - d. If another jurisdiction has lodged a detainer against you, you may be released to the custody of that jurisdiction. Should you be released from their custody prior to the expiration of your period of supervision, or should the detainer not be exercised, you are to immediately contact the Probation Department in your county of last legal residence for supervision instructions.
 - e. The procedure for obtaining a Certificate of Rehabilitation is documented in PC 4852.01 - 4852.21.

CONDITIONS OF POSTRELEASE COMMUNITY SUPERVISION

2. **RELEASE, REPORTING, RESIDENCE:** Unless other arrangements are approved in writing, you will report to your Supervising county agency within two working days following your release. You will inform your supervising county agency of your residence, employment, education, or training. Any change or anticipated changes in residence, employment, education, or training shall be reported to your supervising county agency in advance. You shall inform the supervising county agency of new employment within 3 business days of that entry.
 - a. **SUPERVISING COUNTY AGENCY INSTRUCTIONS AND TRAVEL:** You shall comply with all instruction of your supervising county agency representative. You will not travel more than 50 miles from your residence without prior approval. You will not be absent from your county of residence for a period of more than 48 hours and not leave the State of California without prior written approval of your supervising county agency.
 - b. **CRIMINAL CONDUCT:** You shall not engage in conduct prohibited by law (state, federal, county or municipal). You shall immediately inform your supervising county agency if you are arrested for a felony or misdemeanor crime, or citation. Conduct prohibited by law may result in a revocation by a court to be served in county jail even though a criminal conviction does not occur.
 - c. **WEAPONS:** You shall not own, use, have access to, or have under your control: (a) any type of firearm or instrument or device which a reasonable person would believe to be capable of being used as a firearm or any ammunition which could be used in a firearm; (b) any weapon defined in state or federal statutes or listed in California Penal Code Section 12020 or any instrument or device which a reasonable person would believe to be capable of being used as a weapon as defined in Penal Code Section 12020; (c) any knife with a blade longer than two inches except kitchen knives which must be kept only in the kitchen of the persons residence and knives related to your employment which may be used and carried only in connection with your employment; or (d) a crossbow of any kind.
 - d. **FLASH INCARCERATION:** You agree to waive any right to a court hearing prior to the imposition of a period of "flash incarceration" in a county jail of not more than 10 consecutive days for any violation of your postrelease supervision conditions. You agree to participate in rehabilitation programming as recommended by the supervising county agency.
 - e. You shall sign this agreement and any special conditions imposed upon you by the supervising county agency or the court. If you refuse to sign these or any other conditions impose upon you, the supervising county agency may refer the case to a court for revocation proceedings.

I have read or have had read to me and understand the conditions of release as they apply to me.

**IDENTIFYING COUNTY
OF LAST LEGAL
RESIDENCE**

IDENTIFYING THE COUNTY OF LAST LEGAL RESIDENCE

The County of Last Legal Residence (CLLR) is the county of residence where an offender maintained an address prior to incarceration for their most recent commitment offense.

Correctional Counselors shall document the CLLR on the CDCR Form 611, Release Program Study, (Rev. 08/11), in accordance with previous direction as outlined below:

Enter the **County of Last Legal Residence** in the appropriate box. The following criteria, listed in order of priority, will be utilized to determine the County of Last Legal Residence:

1. First check the inmate's last residence as recorded on the current Probation Officer's Report (POR).
2. If the POR is not available, check for the inmate's last residence as recorded on the arrest report.
3. If the POR or arrest report is not available, if the offender was transient, or if the last legal residence was out-of-state, staff shall use the County of Commitment as the County of Last Legal Residence.

The following are some examples:

1. A transient inmate committed from Los Angeles County is convicted of narcotics trafficking while in custody at the California Men's Colony and receives an additional sentence. The additional sentence is controlling so the Legal Status Summary show the county of commitment as San Luis Obispo. However, for parole purposes, the County of Commitment and County of Last Legal Residence remains the Los Angeles.
2. Here is another scenario: An inmate living in Texas commits an armed robbery in California. In this instance, the prior county of residence is in the State of Texas. Since the inmate has no County of Last Legal Residence in California, the inmate shall parole to the County of Commitment and the case shall be forwarded to the region responsible for that county. The CC I would enter the County of Commitment as the County of Last Legal Residence.
3. The final scenario is an inmate who resided in Orange County and was convicted for selling drugs in Los Angeles County. The Legal Status Summary indicates the county of commitment as Los Angeles and the Probations Officer's Report indicates the County of Last Legal Residence as Orange County. Therefore, Orange County shall be entered as the County of Last Legal Residence.

ACRONYMS

**CDCR MENTAL HEALTH SERVICES DELIVERY SYSTEM
LEVEL OF CARE ACRONYMS**

- CCCMS** - This acronym represents the Correctional Clinical Case Management System. Inmates designated as CCCMS require a lower level of mental health care and are typically housed within the institution's general population.
- EOP** – This acronym represents Enhanced Outpatient Program. Inmates designated as EOP require increased mental health care and are typically housed separately from the institution's general population.
- MHCB** - This acronym represents Mental Health Crisis Bed. MHCB is an acute level of care that provides stabilization and treatment of inmates who are experiencing a severe exacerbation or acute onset of symptoms. These symptoms may result in grave disability, danger to self or others, or other psychiatric issues that require psychiatric observation and initial stabilization for a brief period of time.
- DMH** - This acronym represents California Department of Mental Health level of care and is available for inmates requiring acute or intermediate inpatient mental health care.

Definition of Classification Job Titles

Classification and Parole Representative (C&PR) – responsible for oversight of the Correctional Counselor processes in the general population prisons, including inmate intake into the prison, transfer of inmates to other prisons, and release of the inmates from prison. Also supervises the prison's Case Records Unit.

Correctional Counselor I (CC I) – Case worker responsible for inmate documentation, classification, housing, custody

Correctional Counselor II (CC II) – Supervisor of Correctional Counselor I – responsible for oversight of CC I work.

Correctional Counselor III (CC III) – Supervisor of Correctional Counselor IIs – In the Reception Centers, responsible for oversight of the reception center processing of inmates from the Counties and into General Population prisons.

**CDCR VICTIM SERVICES PROCESS FOR HANDLING RESTITUTION
UPON RELEASE TO PAROLE**

- Once the offenders' accounts have been entered into TRACS, when he/she paroles, the account will go to CFTB (victim orders), or Victim Compensation and Government Claims Board then CFTB (fines).
- For restitution fines, when the offender leaves prison, the unpaid fine account is turned over to the California Victims of Crime Program, who contracts with the California Franchise Tax Board (CFTB) to collect the remaining balance.
- For victim direct orders of restitution, CDCR turns the unpaid balance over to the CFTB for collection. The money CFTB collects on the victim's orders comes back to CDCR, who then connects the proper victims with the collections for distribution to the victims.
