In November 2014, there were 1,657 offenders released from CDCR prisons to PRCS. Of those, 1,276 (77.0%) were GP level, 325 (19.6%) were CCCMS level, 53 (3.2%) were EOP Level, 3 (0.2%) were MHCB level, and 0 (0.0%) were Acute Level of Care.
