In April 2015, there were 1,682 offenders released from CDCR prisons to PRCS. Of those, 1,314 (78.1%) were GP level, 313 (18.6%) were CCCMS level, 51 (3.0%) were EOP Level, 3 (0.2%) were MHCB level, and 1 (0.1%) was Acute Level of Care.
