In August 2015, there were 1,590 offenders released from CDCR prisons to PRCS. Of those, 1,249 (78.5%) were GP level, 276 (17.4%) were CCCMS level, 57 (3.6%) were EOP Level, 2 (0.1%) were MHCB level, and 6 (0.4%) were Acute Level of Care.
