In January 2015, there were 1,833 offenders released from CDCR prisons to PRCS. Of those, 1,473 (80.4%) were GP level, 316 (17.2%) were CCCMS level, 42 (2.3%) were EOP Level, 2 (0.1%) were MHCBS level, and 0 (0%) were Acute Level of Care.
