In September 2015, there were 1,589 offenders released from CDCR prisons to PRCS. Of those, 1,240 (78.0%) were GP level, 294 (18.5%) were CCCMS level, 53 (3.3%) were EOP Level, 2 (0.1%) were MHCB level, and 0 (0%) were Acute Level of Care.
