In June 2016, there were 1,428 offenders released from CDCR prisons to PRCS. Of those, 1,109 (77.7%) were GP level, 274 (19.2%) were CCCMS level, 42 (2.9%) were EOP Level, 2 (0.1%) were MHCBC level, and 1 (0.1%) was Acute Level of Care.
