

**BOARD OF JUVENILE HEARINGS**  
**Executive Board Meeting**  
**April 19, 2018**

**Meeting Called to Order at 9:37 a.m.**

**Roll Call:** Commissioners Bowens, Infante and St. Julien and Executive Officer Stern present.

Executive Officer STERN stated that all of the currently-appointed commissioners are present.

**CONSENT CALENDAR**

Commissioner BOWENS moved to approve the consent calendar. Commissioner INFANTE seconded the motion, which carried unanimously.

**REPORTS AND PRESENTATIONS**

**Report from Division of Juvenile Justice Director, Chuck Supple**

SUPPLE discussed the working relationship that DJJ is continuing to forge with Chief Probation Officers of California (CPOC) and various county stakeholders regarding reentry services and honorable discharge.

SUPPLE shared about a recent visit to Sonoma County with Commissioner BOWENS where a conversation was started about possibly having Probation attend reentry case conferences for DJJ youth nearing discharge. The idea is to include the counties in the reentry planning stages in an effort to further develop the available resources for each youth to increase their chances for success.

SUPPLE encouraged the Board and DJJ to continue working collaboratively with the counties on Senate Bill 625 Honorable Discharge, noting that this measure will not just allow DJJ to produce a recidivism rate, but to recognize youth success.

**Report from Executive Officer, Rachel Stern**

STERN welcomed the Commissioners, DJJ staff and community members to the public meeting.

STERN congratulated Director SUPPLE on his Senate confirmation.

STERN stated that all of the Commissioners attended the 2018 National Council of Juvenile and Family Court Judges annual conference and attended courses in adolescent brain development, new trends in probation supervision, implicit bias, and the use of risk-assessment tools.
