REPORTS

Report from Executive Officer, Jennifer Shaffer

SHAFFER stated that Chief Counsel, JENNIFER NEILL, has been appointed by Governor Newsom as General Counsel for the California Department of Corrections and Rehabilitation. SHAFFER thanked her for her service to the Board, that she will be greatly missed, and that we wish her much success in her new position. Assistant Chief Counsel, TIFFANY SHULTZ is Acting Chief Counsel for the Board, pending the Governor's appointment of a new Chief Counsel.

JILL KLINGE, Alameda County District Attorney's Office, expressed concern that inmates housed out-of-state are disadvantaged by not having a comprehensive risk assessment prepared for their hearing. She recommended that inmates housed out-of-state be returned to California for the preparation of a risk assessment prior to their hearing.

VANESSA NELSON-SLOANE, Life Support Alliance, stated that many stakeholders are uncertain about the structured decision-making process. She recommended additional training.
