**Report from Executive Officer Jennifer Shaffer**

**Report from Chief Psychologist, Forensic Assessment Division, Dr. Cliff Kusaj**

KUSAJ stated that Forensic Assessment Division psychologists also attended the annual training conference of the Association of Paroling Authorities International. Psychologists also received training on the Violence Risk Scale for Sexual Offending (VRS-SO). KUSAJ stated that the VRS-SO would not be used in comprehensive risk assessments at this time. KUSAJ stated that he and other psychologists also attended a weeklong training event at the Department of State Hospitals and that he visited the Guiding Rage into Power (GRIP) program.

**Report from Chief of Office of Victim and Survivor Rights and Services, Katie James**

JAMES gave updates on the launch of the Hearing Reservation Portal for registered victims and their family members to use to indicate they intend to attend a parole hearing and on the apology letter program.

The hearing panel permitted the victims to attend the hearing, but CROSS stated that the relevant regulations do not require victims to provide the requested information as a condition of being able to give notice of intention to attend a hearing.

VANESSA NELSON-SLOANE, Life Support Alliance, stated that the Victims' Letter Bank is now in operation.

MARIA GRIJALVA, Latinos Information and Resource Center, recommended that victims, in their written submissions to the Board, focus on dynamic factors, rather than on the circumstances of the controlling offense.
