- Purpose: to provide a compilation of information related to best practices and evidence-based programs that have been shown to be effective in serving justice-involved youth who have serious behavioral health needs.
- CCJBH has drafted the Request for Proposal and it is currently under internal review.

- The work done through the Compendium and Toolkit will complement the efforts of the Office of Youth and Community Restoration and serve as a key resource for county probation, child welfare, and behavioral health departments.
