# 2021 Annual Legislative Report

- **October:** Draft CCJBH 2021 Annual Legislative Report was completed and circulated with CDCR/CCHCS executives and Councilmembers for review and feedback by October 27<sup>th</sup>.
- **November:** Special Council meeting for a vote to adopt recommendations to be included in the 2021 CCJBH Annual Legislative Report.
- **December:** Final review and submission to the Legislature by December 31.
