BOARD OF JUVENILE HEARINGS

Executive Board Meeting September 26, 2018

Meeting Called to Order at 9:46 a.m.

Roll Call: Commissioners Bowens, Infante and St. Julien and Executive Officer Stern present.

Executive Officer STERN stated that all of the currently-appointed commissioners are present.

CONSENT CALENDAR

Commissioner ST. JULIEN moved to approve the consent calendar. Commissioner INFANTE seconded the motion, which carried unanimously.

REPORTS AND PRESENTATIONS

Report from Director, Chuck Supple

SUPPLE shared an update on the Governor's Budget, specifically Assembly Bill 1812 focusing on DJJ, which in some circumstances has increased the age of jurisdiction to 25. The overall premise for passing measures like this in the budget was based on studies surrounding Adolescent Brain Development, proving that more young adults should be adjudicated to DJJ rather than go to the prison.

SUPPLE stressed the importance of the legislation, broadening DJJ's footprint with the youthful population, giving them the foundation to succeed. SUPPLE reiterated his expectation that all staff have the responsibility to help the youth imagine a different future including jobs, career tech opportunities, and college life. SUPPLE shared his belief in a community building approach to treatment.

SUPPLE stated that the Board of Juvenile Hearings has been given the authority to grant Honorable Discharge to E and M number youth as well as those youth in the Young Adult Program, encouraging them to complete their term in DJJ. An Honorable Discharge certificate will remove barriers that our youth may face upon discharge and reentry into their communities and that the court shall recognize it as proof of rehabilitation.

SUPPLE thanked everyone for their hard work and that DJJ's ultimate approach to treatment is to be seamless, leading our youth to success and aligning their goals to Honorable Discharge.
